

NOVEMBER 11/2025

The annual budget workshop was held on November 11, 2026 at 6:00pm in the Municipal Buiding. Secretary Vicki Koser and Supervisors John Martz Sr. and Shawn Betz went over the proposed budget line by line. The total anticipated monies for 2026 is \$466,000.00 dollars. The Supervisors agreed to no tax increases for 2026. Secretary will advertise the budget is prepared and will be adopted at the regular December meeting to be held on December 9, 2025. The budget workshop came to close by 6:30pm when the regularly scheduled November was then called to order.

The minutes were approved by motion of John and seconded by Jack. The call vote was 3 yes.

Ben Shaffer and Caden Freyre from Bucknell University were present to speak on a bike race.

The Bucknell cycling team is hosting a bike race this spring and will be using the Montour Preserve as the venue and race on some of the surrounding roads in Derry and Anthony Townships.. The students took questions from the audience. They will have a safety plan in place and documents to aleve the Township of any liability. They will be using local fire departments for directing traffic and providing EMTs. They were asked if they ever raced in Amish country and it was suggested as a courtesy to speak with one of the Amish Bishops. The Board of Supervisors is in favor and will give final approval at the December meeting.

Several member of the public spoke again in oposition to the Talen rezoning request. Severla more letters were received for the public record. Concerns on water usage and loss of Ag farmland , noise levels were heard. Kelly Smith-Wells questioned wether Bruce and Kelly Miller's son George will be recusing himself from the situation since the family property could be included in the rezoning. George in a member of the NMRPC. Greg responded we will not remove him from his position and and recusal will be his decision.

Solicitor spoke next and asked the Board if they would like to request the NMRPC to amend their ordinance to include a section on data centers and putting a moratorium on land development for data centers pending and amendment to the ordinance. Supervisors agreed to do so by motion of Greg and esecoded by Shawn. The call vote

was 3 yes.

The Board next adopted and approved the Regional Solid Waste Management Plan as its own municipal waste mangment plan and authorized submittal of the Regional Waste Management Plan to PA DEP for review and approval by motion of Greg and seonded by John. Call vote 3 yes. The Montour County 2025 Hazard Mitigation Plan was adopted as the offical Hazard Mitigation Plan of Derry Township by motion of Greg an seconded by Shawn. The call vote was 3 yes.

Greg read a letter of interest from Robert Wells to fill the seat on the NMRPC that was vacated by Bruce Miller. Robert Wells was approved by motion of Greg and seconded by John. The call vote was 3 yes.

The Treasurer report was appoved by motion of Shawn and seconded by John the call vote was 3 yes. The bills were accepted for payment expect for the one from Medico. John Martz is working on getting the bill reduced. The motion was then made to pay the other bills by motion of Shawn and seconded by John. The call 3 yes.

John reported that he had to purchase a new pole saw. With no further buisness the motion to adjourn was made by Shawn
